Looking Beyond our Borders

European Theme for the EMBRACE Spring Meeting

The Northern Ireland 2011 Census revealed that over 45,000 people living here had been born in European countries other than the UK or the Republic of Ireland. Europe has come to us. As churches here consider how to respond they can look to Europe to see what churches there are doing about community integration and in challenging the injustices that can accompany migration. EMBRACE is privileged to have as guest speaker at their spring meeting, **Dr Torsten Moritz**, Executive Secretary for the **Churches' Commission for Migrants in Europe** (**CCME**). The meeting is entitled 'Migration: it's about Europe, it's about you'.

CCME provides a space for churches and Christian agencies to share their experiences in ministry among migrants, refugees, and minority-ethnic people and is part of the wider ecumenical networks of the Conference of European Churches (CEC) and the World Council of Churches (WCC). They network with European institutions and encourage the implementation and harmonising of the highest international standards in the treatment of migrants and refugees. http://ecumenicalvoices2014.eu/a-europe-union-which-welcomes-and-protects-migrants-and-refugees/

Dr Moritz will share something of the emerging issues relating to migration in Europe and some of the experiences and good practice of local churches as they respond to the issues and welcome newcomers.

Pope Francis Addresses Vatican Conference on Human Trafficking

A conference was held at the Vatican in April 2014, at the instigation of the Bishops' Conference of England and Wales and in collaboration with law enforcement agencies from the UK. In his address the Pope acknowledged that the conference drew upon the expertise of the law enforcement authorities, but also noted the presence of

humanitarian and social workers, whose task it is to provide victims with welcome, human warmth and the possibility of building a new life. These are two different approaches, but they can and must go together. ...

Human trafficking is an open wound on the body of contemporary society, a scourge upon the body of Christ. It is a crime against humanity. The very fact of our being here to combine our efforts means that we want our strategies and areas of expertise to be accompanied and reinforced by the mercy of the Gospel, by closeness to the men and women who are victims of this crime.

Nigerian Cardinal John Olorunfemi Onaiyekan, the Archbishop of Abuja has worked against human trafficking for decades, along with fellow Christians, missionaries, religious and lay activists whom he calls the real 'foot soldiers'. He said 'The Gospel of God's mercy, freedom and love, preached by the Church, is rejected in practice, with human beings being treated as slaves.' www.catholic-ew.org.uk/Home/News/Popeon-Trafficking/(language)/eng-GB

At the end of the conference senior police officers from around the world promised to fight to end human trafficking. 'No Place To Go': BBC Radio Ulster Documentary

Destitution within the asylum system was highlighted in a Radio Ulster programme, aired in February 2014. People who have been refused asylum but are unable to go home are not allowed to work and are without state support. Some people who are in that situation expressed gratitude for the generosity of local people, such as members of the Belfast Friendship Club, and churches and charities such as St Vincent de Paul. Radio Ulster presenter Chris Page said 'lt's a limbo-like life with churches and charities filling the gap.' Women on the Move Honours Lilian Seenoi

Lilian is a refugee from Kenya who was honoured in March 2014 as Woman of the Year for setting up and running the North-West Migrants Forum in Derry~Londonderry. Lilian sought asylum here after her work rescuing young girls from early marriage put her life in danger. She now helps to bring together people from migrant groups and established communities. Speaking at the awards ceremony in London Lilian quoted from the Migrant Manifesto:

I have witnessed how fear creates boundaries, how boundaries create hate and how hate only serves the oppressors. I do understand that migrants and non-migrants are interconnected. When the rights of migrants are denied, the rights of citizens are at risk. Dignity has no nationality.

Between I April 2012 and 31 March 2013, the 24-hour helpline received 272 calls from foreign nationals and black and minority-ethnic people from 34 countries or nationalities. The largest number were 64 calls from Polish women.

Northern Ireland 2013 Human Trafficking Figures

In 2013 there were 1,746 referrals of potential human trafficking to the National Referral Mechanism in the UK, of which 41 were referred from N Ireland, 25 female and 16 male: a 173% increase on 2012. Of the female referrals, 10 of the adults were referred for sexual exploitation and 1 for labour exploitation and 10 of the minors were for sexual exploitation and 4 for an undefined exploitation type.

8 of the adult male referrals were for labour exploitation, I for sexual exploitation, and I other. The one minor male referred for sexual exploitation was from the UK.

The top countries of origin for referrals were: Romania 12; UK II; China 5; Republic of Ireland 5; Nigeria 3; and Egypt, Guinea Bissau, Philippines and Poland I each. www.nationalcrime agency.gov.uk/publications/139-national-referral-mechanism-statistics-2013/file

Sad News

The refugee and minority-ethnic support communities have been shocked by the sudden death of two people who worked on behalf of others with care and respect. One was **Joe Donnelly** of the NI Housing Executive who looked after the housing needs of people who seek asylum here with great sympathy. The second was **Margaret Donaghy**, whose work within Bryson Intercultural promoted the wellbeing of Irish Travellers and members of the Roma community and who was manager for the asylum advice team. They are both remembered very fondly by all who knew them.

'Journeying Together' Conference on Migration

In February 2014 the Irish Episcopal Council for Emigrants (IECE) joined with the Council for Immigrants of the Irish Catholic Bishops' Conference (IECE) to organise a conference, Journeying Together – Challenges Facing the Migrant Today, to explore both emigration and immigration and offer a platform to discuss the effects of migration on undocumented people, families, prisoners and victims of trafficking.

Migration is an intrinsic part of the DNA of a globalised economy and a globalised world. Do we really accept this and what are the consequences? ... At the root of this affirmation is the fundamental principle of the interdependence of all of us as members of the one human family. When God created humankind he created us as a family, with obligations and responsibilities toward each other.

Meaningful Welcome

During the Journeying Together conference, **Cecilia Taylor-Camara**, now a senior policy advisor on migration for the Catholic Bishops' Conference of England and Wales, told delegates how it took some time before she felt fully welcome in the Catholic parish her family joined after they were forced to flee from Sierra Leone to England. Being given even small responsibilities were very important.

One morning I was asked to do the First Reading at Mass. Shortly afterwards, I responded to a call for volunteers to staple the booklets for Holy Week. I began to feel a sense of purpose and belonging in the parish community. A few weeks later the parish priest asked to see me in the sacristy after Mass. It was the first day I entered the sacristy and he asked if I would like to become a Catechist for the Saturday class. ... This was a breakthrough. My reply was an emphatic 'Yes Father'.

EMBRACE Workshops

Partnership with the Rural Community Network (RCN)

RCN has partnered with EMBRACE to organise three workshops for local churches in **Markethill**, Co. Armagh; **Enniskillen**, Co. Fermanagh; and **Newtownards**, Co. Down. These informal sessions allowed people an insight into the effect of recent migration in their local area and an opportunity to hear about church initiatives in nearby localities and elsewhere.

Belfast Bible College Gospel of Welcome Seminars

On Friday IIth April EMBRACE led a seminar on **Refugees** and **People Seeking Asylum** at the Bible College. It provided an overview of the local situation including the number of people who come here to seek sanctuary and the countries they come from. Participants heard a first-hand account from someone who had been forced to flee for safety to N Ireland. They also learned about practical Biblical responses from local Christian groups.

A second seminar, **Stories of Migration**, will be held on 2nd May. It will provide background information and the opportunity to discuss what the Church's role and response might be to newcomers from other countries.

The Hear My Voice DVD (see Building a Welcoming Community 27) was launched at Clonard Monastery in January as part of the interdenominational Four Corners Festival. A total of £1,834.70 was expended from the Emergency Fund between October and March through the following organisations: Educational Welfare, Belfast Education and Library Board; NI Community of Refugees and Asylum Seekers; Migrant Help; Belfast Migrant Centre; South City Resource Centre, Belfast; Bryson Intercultural; Horn of Africa People's Aid NI; Homeplus; and Barnardos. The nature of the support was as follows: £480 for school uniforms and bus fares for five families who were ineligible for state support; £798.72 for flights home one to Canada and three to Romania; £50 towards emergency; accommodation for one person £155 towards food and basic needs in six cases; and £193.98 for electricity and heaters for four families.
